UNDERSTANDING YOUR BILL

Energy Charges

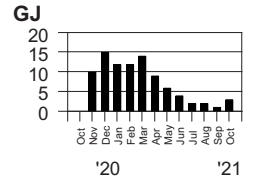

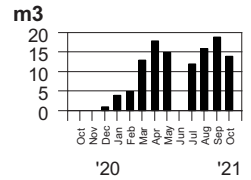

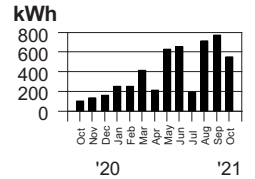
